## Following is an excerpt from the bylaws of CECA detailing important information about director nominations.

### ARTICLE III • DIRECTORS

#### SECTION 3.2. QUALIFICATIONS AND TENURE

A. To be eligible to become or remain as Director or to hold any position of trust in the Cooperative, a Member must:

1. be a bona fide resident in the area served by the Cooperative,
2. be receiving electric service from the Cooperative at their primary residence,
3. be a citizen, or legal resident, of the United States,
4. not, within the past ten (10) years, have been convicted of a felony nor of any crime involving moral turpitude,
5. not be employed nor have a material financial interest in a competing enterprise, or in a business selling electric energy or supplies to the Cooperative,
6. not be, or have been, an employee of, nor received compensation from, the Cooperative for the longer term of:
  - a. 5 years prior to the election, or
  - b. for so long as the individual's former Cooperative supervisor remains employed by the Cooperative.

#### SECTION 3.3. DISTRICTS PLAN

**DISTRICTS DESCRIBED.** The territory served or to be served by the Cooperative shall be divided into seven (7) Districts, and each District shall be represented by one (1) Director who is a resident of that District. Said seven (7) Districts shall be from time to time reviewed and constituted by the Board of Directors, with notice of the district descriptions provided to the Members in advance of the annual director nomination process.

Not less than seventy (70) nor more than ninety (90) days before the annual meeting of the Members in each year for the election of Directors, the board of Directors shall review the composition of the several Districts and if it should be found that inequalities in representation have developed which can be corrected by a re-delineation of Districts or by the addition of Districts, the board of Directors shall reconstitute the Districts.

**Director Terms.** A Director's term begins: 1) after the individual consents to being elected or appointed as a Director; and 2) at the beginning of the first Board Meeting held after the Director is elected or appointed. A Director's term ends after: 1) a successor Director consents to being elected or appointed as a Director; and 2) at the beginning of the first Board Meeting held after a successor Director is elected or appointed. Directors' terms shall be three (3) years. Directors shall be elected on a staggered-term basis.

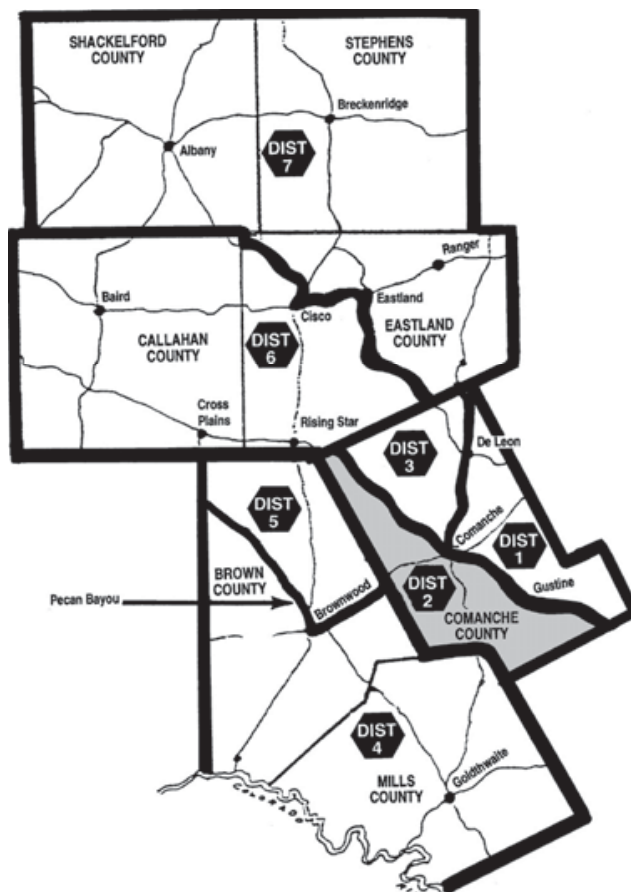
**Director Resignation.** A Director may resign at any time. To resign, a Director must sign and deliver a written notice of resignation to the Board, President, or Secretary. Except as a later date is otherwise provided in a written notice of resignation, a Director's resignation is effective when the Board, President, or Secretary receives the written notice of resignation. If a Director's resignation is effective at a later date and if the successor Director does not take office until the effective date of the Director's resignation, then the pending Director vacancy may be filled before the effective date of the Director's resignation.

**Nomination of Directors.** Not less than thirty (30) nor more than ninety (90) days before the annual meeting of Members for the election of Directors, the Board of Directors shall call a meeting or meetings of the Members of such Districts as are to have vacancies for Director, such meetings to be held not less than twenty (20) days prior to the annual meeting of the Members at suitable places in or near the Districts affected.

The purpose of the District meetings shall be to nominate, by vote of those Members present in person, no more than two candidates for each vacancy occurring on the Board of Directors. Notice of each District meeting of Members shall be given by the Secretary for such length of time and in such manner as the Board of Directors may direct provided that notice stating the place, day and hour and the purpose of such meeting, shall be given by mail, publication, or electronically not less than ten (10) days prior to such District Meeting. Such District Meetings however, shall be open for discussion of any other matters pertaining to the business of the Cooperative, regardless of whether or not such matters were listed in the notice of the meeting, and recommendations with respect thereto may be submitted to the Board of Directors.

The first order of business at each District Meeting shall be the selection of a Chairman, who shall appoint a Secretary to act for the duration of the meeting. Fifteen (15) of the Members residing in the District present at such duly called District

Meeting shall constitute a quorum, but in the event a quorum is not present at such meeting, the Director then serving such District shall be the official nominee for such District. In addition, the Board shall establish deadlines and appropriate forums in order to allow any qualified Member of such Districts to obtain petitions bearing the signatures of at least 30 District Members in order to be nominated and have their name placed on the ballot for election of that District's director election. There shall be no nominations from the floor at the Annual Meeting.

**Director Candidates,** who have been nominated, either at a District meeting or by petition, shall be required to execute an appropriate form to be made available to election judges attesting that the candidate is qualified under these Bylaws to be elected and serve as a Director of the Cooperative.

**Voting** shall be in person only. Mail-in ballot and proxy voting shall not be permitted at any District Meeting. Each Member present may vote for one nominee as above provided for such District. The two candidates for each place on the Board of Directors receiving the highest number of votes shall be the official nominees of the District. The minutes of such District meeting shall set forth, among other matters the name of each person nominated at the meeting and the number of votes received by each and shall certify the two nominees receiving the highest number of votes as the official nominees of the District for Director. A certified copy of the minutes, signed by the Secretary and the Chairman of the District Meeting, shall be delivered to the Secretary of the Cooperative within five (5) days after such District Meeting.

The Secretary of the Cooperative shall prepare and post at the principal office of the Cooperative at least fifteen (15) days before the meeting of Members for the election of Directors, a list of nominations for Directors as shown by said certified copies of minutes of said District Meetings. The secretary shall mail with the notice of the meeting of the Members for election of Directors, or separately, but at least ten days prior to the meeting, a statement of the number of Directors to be elected and showing separately the nominations made by the respective Districts.

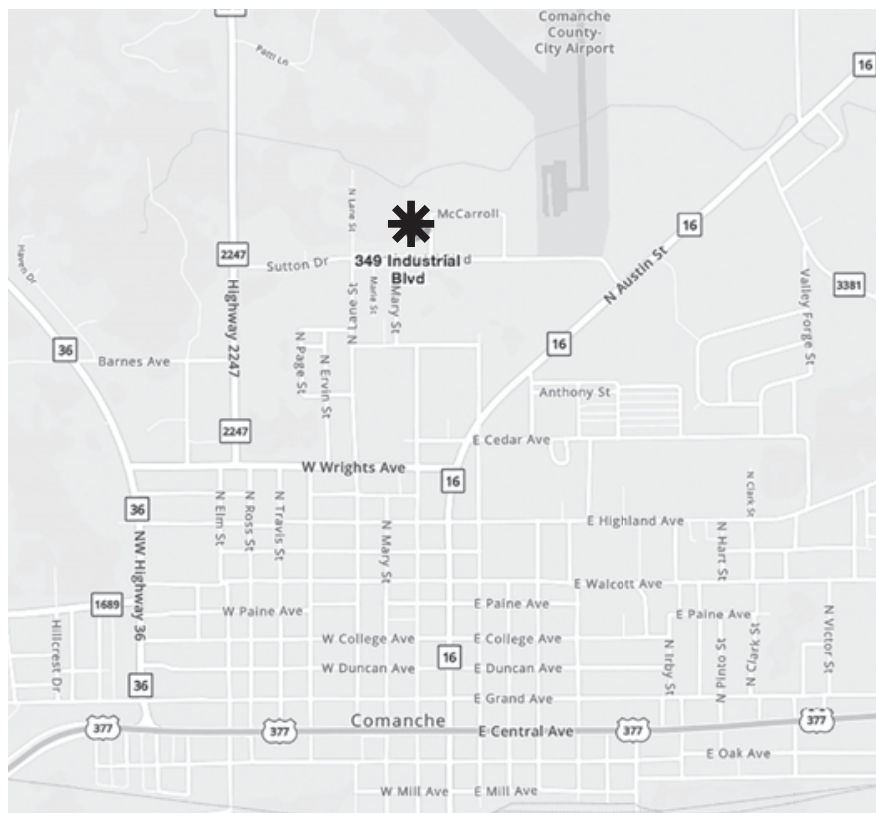

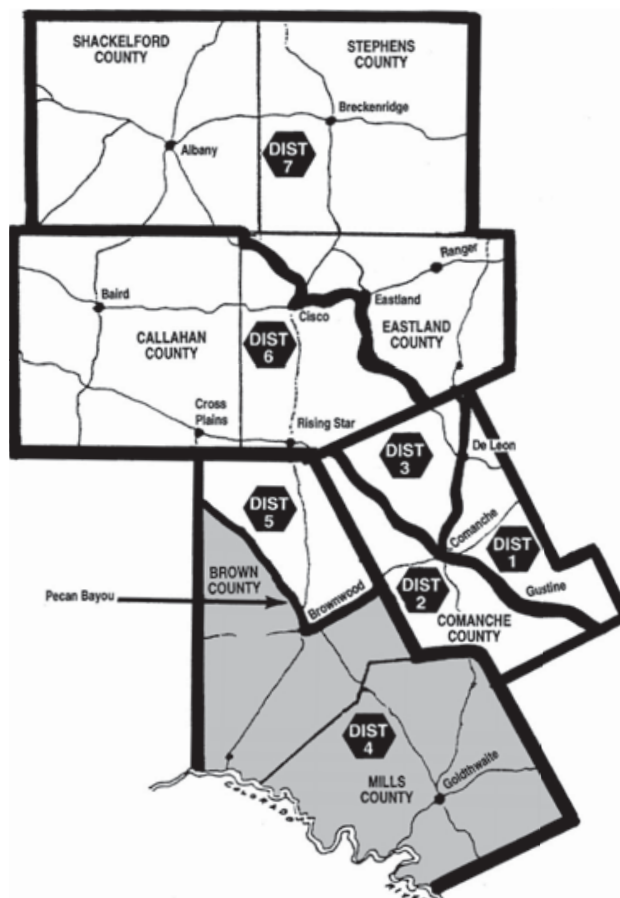

# Be Wary of COVID-19 Scams

**AS THE CORONAVIRUS** pandemic continues to effect the United States, scammers have seized the opportunity to prey on consumers, including electric co-op members in Texas.

The Federal Communications Commission has received reports of scam and hoax text message campaigns and scam robocalls offering free home testing kits, promoting bogus cures, selling health insurance and exploiting virus-related fears.

Scammers sometimes call to say that an electric bill is past due and try to collect personal information, such as Social Security numbers, or immediate payment through wire transfers, prepaid debit cards, gift cards or other untraceable currency. Members should be especially wary if anyone comes to your door to collect payment.

When CECA calls you, we will have your name and address; our member service representatives will not ask for that information over the phone. Never give out personal information to a stranger over the phone or at the door, and don't let strangers inside your home.

If you are suspicious or feel threatened by a caller or visitor, call law enforcement immediately. If you get a call from a scammer pretending to be from your electric cooperative,

hang up and call CECA directly at 1-800-915-2533.

Opportunists are also offering air conditioning duct cleaning as a way to "protect" your home and family from the virus.

The FCC warns of an increase in messaging scams, in which an email or text may falsely advertise a cure or an offer to be tested for coronavirus. Do not click on these links.

Some text scams impersonate government agencies. The FCC has learned of a text scam claiming to be from the "FCC Financial Care Center," offering \$30,000 in COVID-19 relief. There is no such FCC program.

The Better Business Bureau warns of a text message scam impersonating the U.S. Department of Health and Human Services that informs recipients that they must take a "mandatory online COVID-19 test" or that diabetic patients can receive a free testing kit and blood glucose monitor using an included link. Again, don't click the link.

Text message hoaxes may claim that the government will order a mandatory national two-week quarantine or instruct you to go out and stock up on supplies. These fake messages may even appear to be from a "next-door neighbor."

Fraudsters are also preying on financial fears. The FCC is aware of scams based on COVID-19 work-from-home opportunities, student loan repayment plans and debt consolidation offers. Small businesses are also getting scam calls about virus-related funding or loans.

If you think you've been a victim of a coronavirus scam, contact law enforcement immediately.

## Protect Against Scams

- Do not respond to calls or texts from unknown numbers or any others that appear suspicious.
- Never share your personal or financial information via email or text message or over the phone.
- Be cautious if you're being pressured to share any information or make a payment immediately.
- Scammers often spoof phone numbers to trick you into answering or responding. Remember that government agencies will never call you to ask for personal information or money.
- Do not click any links in messages. If a friend sends you a message with a suspicious link that seems out of character, call them to make sure their accounts weren't compromised.
- Always check on a charity (for example, by calling or looking at its actual website) before donating.

## Have a Safe Fourth of July

**FIREWORKS ARE A MUCH-ANTICIPATED HIGHLIGHT** of the Fourth of July but also present a significant danger.

The best option is to attend a public fireworks display and leave it to the professionals, but if your holiday isn't complete without setting off a few of your own, please take these precautions:

- Follow all local laws, and read and follow product directions.
- Do not allow children to handle fireworks.
- Make sure fireworks are used on a hard, stable surface in an open, clear area, and never attempt to relight a "dud."
- Make sure there is water nearby in case of an emergency.
- Wear ear protection.
- Never light fireworks in a container.
- If swimming is part of your plan, make sure children are always supervised in or around the water. Take responsibility for your children even in the company of other adults. Consider hiring or nominating a lifeguard.
- Many people travel over the holiday, and congestion, accidents, road rage and impaired driving can quickly turn the holiday into a tragedy. Make sure your car is in excellent condition and that you are rested, alert and sober if you are driving. Plan ahead for a designated driver if appropriate.
- If barbecue is on the menu, be careful when lighting the grill, and make sure an adult is always present around a heated grill. Be sure to put away perishables to avoid eating spoiled food. Make sure to cook meats thoroughly on the grill.
- Watch out for signs of heatstroke, such as hot, red skin; changes in consciousness; a rapid or weak pulse; and rapid or shallow breathing. If you suspect someone is suffering from heatstroke, call 911.
- And don't forget to take special precautions with your pets. Fireworks can be terrifying for them, so keep them indoors or in another safe place.
- Drink plenty of water, wear sunscreen and have a wonderful Independence Day.

*Do you run from change, or do you embrace it? We live in a rapidly changing world, and, like it or not, change is inevitable. At CECA, we strive to keep pace with the latest technologies. Doing so necessitates change, and in the case of technology, change is good.*

## SCADA

Supervisory control and data acquisition, or SCADA, is a system of software and hardware elements that allows CECA to quickly spot and resolve power outages—which means safer, more reliable electricity for you, the co-op member.

This system has proved instrumental in creating operational efficiencies, reducing outage duration and promoting proactive distribution system maintenance. SCADA offers system operators a systemwide perspective via map board displays while also providing granular detail on station- or area-specific displays.

CECA has focused on automating its distribution system and integrating SCADA functionality into its existing advanced metering infrastructure, outage management system and geographic information system. Integrating these systems has improved outage performance during large-scale outages and created better overall situational awareness. System diagnostic and display pages can be viewed on a computer or iPad by remote users.

## Metering

CECA recently replaced all existing meters with Sensus meters. This AMI solution allows CECA to automatically collect consumption, diagnostic and status data from members' meters and transfer that information to a central database for billing and analysis.

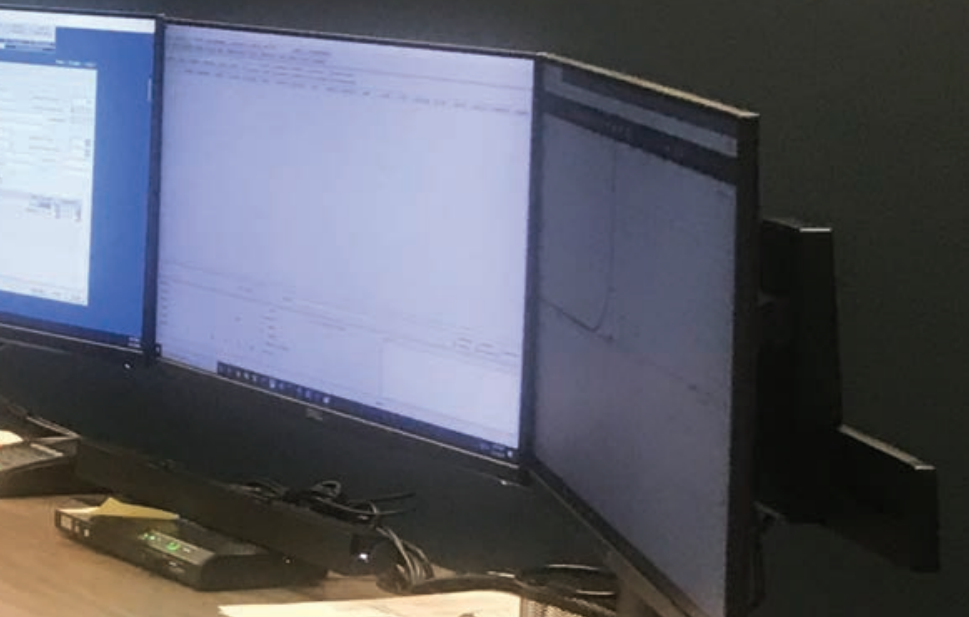
This system allows for real-time billing information, reduces estimated reading and billing errors, and increases information about usage while empowering you, the member, to conserve resources and save money.

In addition, the new meters have the ability to immediately notify the cooperative's dispatchers of an outage—often before the member is even aware their power is off. This important feature allows cooperative personnel to be dispatched in a more timely manner, ensuring more efficient power restoration.
