Renewal Required for Ag/Timber Sales **Tax Exemption**

IF YOU ARE CLAIMING a sales tax exemption on electricity used in the production of agricultural or timber products, you must renew your exemption by December 31 through the Office of the Texas Comptroller of Public Accounts. Otherwise, the co-op will be required to charge sales tax beginning in January.

How To Renew Exemption Certificates

There are several options for renewing your exemption certificate: online, by phone or by mail. Online renewal is the fastest, with the applicant receiving a confirmation number immediately. Those applying by phone will receive a confirmation letter by mail in five to seven days. Processing time for renewing by mail could take several weeks.

Those seeking a renewal can visit comptroller.texas.gov/taxinfo/agriculture/ get ready texas.html for more information. The site also features a list of eligibility requirements.

Only one certificate is required for members with multiple qualifying meters.

CECA Annual Meeti

OCTOBER 10 TURNED OUT TO BE an exceptionally beautiful day for a celebration under a big tent, when more than 600 people attended Comanche Electric Cooperative's 77th Annual Meeting of the Membership at the Comanche City Park.

Upon entering the park, members were greeted and registered by enthusiastic CECA employees. They were presented with the CECA Annual Report, a ballot and other important information concerning the cooperative, along with an ecoPOWR energy-efficiency kit and a stadium/picnic blanket featuring the CECA logo. Soft drinks, water and popcorn were dispensed by CECA personnel, and members and their guests were given the option of attending the entertainment provided by The Class of '57, and/or a health fair with the following vendors present: Air Evac Lifeteam, Abilene Behavioral Health, Comanche County Medical Center, Comanche WIC,

Cross Timbers Health Clinic, STARRY Counseling, Tanglewood Pharmacy, The ARK, Texas Department of Family and Protective Services and Western Hills Nursing Home.

Adults were not the only ones enjoying the circus-tent atmosphere. Happy little faces of children were filled with delight as they filed into the big tent. Ashley's Twist and Paint was available to paint pint-sized faces with a variety of designs, ranging from superheroes to

unicorns, and to twist balloons into amusing shapes. On the other side of the tent, CECA employees Brandon Cook and Ryan Harris placed yellow hard hats on the heads of adventurous youngsters who dared to venture off the ground in bucket-truck rides.

At 10 a.m., the meeting officially commenced when Comanche Boy Scout Troop No. 67 presented the colors and led the Pledge of Allegiance, followed by the national anthem sung by Carissa Cole.

General Manager Alan Lesley opened the meeting with a short prayer. Reports were given by Ruby Solomon, secretary of the board; David Copeland, CPA from Bolinger, Segars, Gilbert & Moss; and Don Richards, legal counsel for CECA.

Special guests in attendance were: Dr. J.D. Sheffield, state representative for District 59, and his District Director Gary Kafer; and Dr. Dawn Buckingham, candidate for state Senate. Sheffield was given the opportunity to speak and gave

a humorous rendition of a family story concerning an event he still remembers about his "Mamaw" before electricity.

Lesley addressed the membership, extolling the uniqueness of the cooperative model. He expanded on the meeting theme of "The Power of Giving Back" by giving examples of the many ways CECA is involved in the communities in which it serves. Lesley gave several examples of CECA's commitment to community, including this one: "At our core, the

cooperative exists to meet community needs. We are committed to working with you, our members, on issues you care about. As you well know, the areas we serve are rural. And some are more rural than others.

"The Mullin Volunteer Fire Department sits in one of these areas. When faced with the challenge of providing a safe area in which to land an air ambulance, they set out to find a solution. Working through Comanche Electric Cooperative's Operation Round-Up Program, they were able to acquire the funds to build a helipad. This site is now known to both ground and air medical personnel as the place to meet when transferring patients to trauma centers. Embracing this idea as something that would prove valuable to other small communities, CECA has since partnered with the communities of Gorman and Wayland to build similar facilities in their areas.

"Now, looking forward and planning for the future, CECA has recently purchased a 15-acre tract of land and warehouse building close to the Comanche Airport. Once renovated, this facility will not only serve as our new headquarters, but also support a large community facility capable of hosting events such as this annual meeting and other civic-minded gatherings. With proper planning, we are helping to build and strengthen our community. Motivated to provide more than electricity, we are helping to empower the communities we serve."

Lesley closed by emphasizing that it is CECA's concern for community that sets it apart from other entities. "We're here because we believe life can be better. It won't do to wait for someone else to fix problems for us—we know we can do anything with the power of cooperation."

A purpose of the meeting is to elect directors to represent the membership. Districts 1 and 7 previously had met and nominated incumbents Randy Denning and Phil Taylor to represent their communities on the board. With no other nominations from the floor, Richards called for and received a motion and a second to elect Denning and Taylor by

acclamation. The motion passed.

Before ending the business part of the meeting, Lesley complimented all employees for their dedication and hard work during some difficult moments during the year. Seven employees reached five-year milestones in their careers and were presented with service awards. Shirley Dukes and Kellie Deters each received a 25-year pin and a commemorative watch to celebrate their co-op careers. Pam McClain received a 15-year pin; Brandon Cook and Dale Ogle received 10-year pins; and David Cisneroz and Tommy Hesbrook received five-year pins.

Back by popular demand, a meal of fried fish and chicken, catered by Cook's Fish Barn, was the final and one of the most-anticipated events of the day. As the final door prizes were being drawn, members followed their noses to the lunch line.

If you made it to the meeting, CECA thanks you. If you did not, we invite you to plan on attending the 78th Comanche Electric Cooperative Annual Meeting to be held in October 2016.
